REGISTRY RULES IN SUMMARY

1. **Who Shall Register** - The owner of the dam at the time the calf was dropped shall register the animal.
2. **Breeder** - The person owning the dam at the time of service is the breeder.
3. **Breeder's Prefix** (if registered) must be used in naming embryos or calves sold in dam.
4. **Tattoo** - Every animal must be tattooed or double tagged (official AIN tags) before it can be registered.
5. **Breeding Information**
 - A. **Date Bred** - Fill in regardless of whether the female was bred naturally or by A.I. If animal was pasture bred, give the dates the bull had access to the dam.
 - B. **Service Certificate** - A service certificate is required for natural service when the owner of the dam at the time of service is not the owner of the sire.
6. **Registering IE Females**
 - A. **Step II** - the prefix "IE" must be used preceding all names and is included in the limit of 27 letter spaces. Step II females are registered in the IE Herdbook.
 - B. **Step III** - the prefix "CIE" must be used preceding all names and is included in the limit of 27 letter spaces. Step III females are registered in the Official Herdbook.
7. **Registering Twins or Multiple Births**
 - A. In registering twins or members of other multiple births, the sex of the other individual(s) must be stated on the Application for Registry.
 - B. **Suffix** - The words **TWIN, TRI, or QUAD** must be used as an integral part of the name as a suffix in the naming of all animals which are members of multiple births.
8. **Off-Color Spots** - A bull having a sharply contrasting off-color spot or spots (anywhere on the body, including the belly) or having a white core in the switch or a female having a sharply contrasting off-color spot or spots above the underside of the belly or above the udder or the floor of the chest, or having a white core in the switch, is considered to have an "Off-Color Spot." The characteristic mealy band around the muzzle, the light colored line up the back, and light area around the poll and horns shall not be considered an "Off-Color Spot." The letters "OCS" must be used as a suffix in naming such an animal.
9. **Signature for Firm or Partnership** - All firm or partnership applications should be signed in the name of the firm or the partnership and countersigned by an authorized person.
10. **For more information** concerning naming, prefixes, duties of owner, etc., please consult the leaflet entitled "Rules and Regulations Governing Registration and Transfer of Brown Swiss Cattle." You may obtain a copy free of charge from the national office or your field representative.
11. **Current fees** available from the national office.
12. **Registering Bulls** - All bulls are required to be parentage tested using genomics at time of registration. Only purebred bulls from officially registered parents may be registered. Bulls are **NOT** eligible for the Identity Enrollment Program (NO ID, IE, or CIE). If you want genomic results, an additional fee applies.
13. **Animals resulting from Embryos** require a suffix to the name: if Conventional = ET; if IVF = ETV .

When an animal is sold, it is the responsibility of the owner (seller) to complete the transfer and to pay the transfer fee in order that the new owner (buyer) is recorded on the Certificate of Registry and the Association's records.
